(57) CLAIM

The ornamental design for a flexible stand-up tapered spouted pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the flexible stand-up tapered spouted pouch, the rear view being a mirror image thereof, showing our new design;

FIG. 2 is a top view thereof;

FIG. 3 is a left-side view, the right-side view being a mirror image thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a top, front, left perspective view thereof when filled:

FIG. 6 is a front view of a second embodiment of our new design, the back view being a mirror image of the front view; FIG. 7 is a top view thereof;


FIG. 8 is a left-side view, the right-side view being a mirror thereof;


FIG. 9 is a bottom view thereof; and,


FIG. 10 is a perspective view thereof when filled.

In FIGS. 1-10, the oblique shade lines on the surface portions indicate contour and not surface decoration. The shaded areas indicate heat-sealed edges of the bag and are not surface decoration nor part of the claimed design. Broken lines show environment and boundaries that form no part of the claimed design.







